Invitation to Bid

Re: 2018 Street Repairs Program

Dear To whom it may concern:

The Village of Richton Park requests bids for the 2018 Street Repairs Program for work to be performed throughout Village limits. This work will include Hot-Mix Asphalt (HMA) pavement patching including full-depth saw cutting; driveway apron replacements as due to damage from construction (between curb and sidewalk); HMA removal for larger areas; HMA surface using a paving machine; and paint pavement markings.

Any Proposals submitted unsealed, unsigned, fax transmissions, e-mails or received subsequent to the aforementioned date and time, may be disqualified and returned to the bidder. Offers may not be withdrawn for a period of ninety (90) days after closing date without the consent of the Board of Trustees.

The Village of Richton Park reserves the right to reject any and all proposals or parts thereof, to waive any irregularities or informalities in proposal procedures and to award the contract in a manner best serving the interest of the Village. This proposal is separated into three sections listed below as Quotes 1 through 3.

Please note that the total number of repairs/stripping will be adjusted to meet budgetary limitations. This work shall follow all applicable portions of Sections 406, 440, 442, and 780 of the Highway Specifications except as noted herein. Asphalt patches and driveway pavement shall be constructed in two lifts; one 4-inch lift of Hot-Mix Asphalt Binder Course, and one 2 - inch lift of Hot-Mix Asphalt Surface Course.

The successful bidder must furnish a satisfactory performance bond and a contract bond in the full amount of the bid. The successful bidder must submit a certificate of insurance prior to the start of work.
