During this past reporting year, we had **15** liquor licenses issued and **8** reported police involved incidents.

# Report Summary

**Licenses** – During **2019** there were **15** liquor licenses re-issued to existing businesses. A listing of liquor licenses by classification and fees paid is included with this report.

A total of **\$17,950** was collected in licensing fees for the various classifications established by ordinance.

**Incidents** - During **2019** there were **eight** incidents requiring police intervention or action.

The **eight** incidents occurred at the following liquor establishments:

- Lakewood Bowl (four incidents)
- Red Star Cocktail Lounge (four incidents)

On January 27, 2019, police were dispatched to Lakewood Bowl in regards to a disturbance with a subject requesting an ambulance. Two subjects were involved in a fight where Pepper spray was used. The fight occurred near the bar. A bystander was transported to the hospital due to the incident. No liquor violations were observed in regard to this incident.

On February 9, 2019, police were dispatched to Lakewood Bowl in regards to an intoxicated subject. Security advised the subject to leave but he would not. The subject was transported to the police department. No liquor violations were observed in regard to this incident.

## **Incidents (continued)**

On February 17, 2019, two females started to fight inside of Lakewood Bowl. Richton Park Police were notified by the staff of the fight while the parties were inside. Security escorted the parties outside where the fight continued. All of the parties involved in the fight refused police assistance. The parties left without further incident. No liquor violations were observed in this incident.

On February 17, 2019, at Lakewood Bowl, multiple subjects were fighting in the restroom. An employee called police, however, the caller refused to speak with officers and left the area. No liquor violations were observed in this incident.

On April 6, 2019, security of Red Star Cocktail Lounge contacted police to report a fight with shots discharged. The offender was not located and the crowd was unruly and uncooperative during the incident. Police spoke with the owner who stated they were attempting to get the crowd to leave, when the crowd began to fight in the parking lot. No liquor violations were observed in this incident.

On May 25, 2019, police were dispatched to a report of a vehicle being left unsecured by Red Star Cocktail Lounge. The intoxicated owner of the vehicle left Red Star and got into his vehicle. A witness stated that owner of the vehicle tried to leave the parking lot and drove over the curb damaging the tire. The subject got into another vehicle and left the area. No liquor violations were observed in this incident.

On October 5, 2019, a customer was asked to leave by security at the Red Star Cocktail Lounge after causing a disturbance. Once the subject was outside, she started a physical altercation with two or three of her friends. The customer was asked to leave by police. No liquor violations were observed in this incident.

## **Incidents (continued)**

On October 5, 2019, police were dispatched to the Red Star Cocktail Lounge for a report of two subjects fighting in the parking lot. After speaking with the subjects, it was discovered that three subjects were fighting; one subject left on foot, and the other two subjects were uncooperative with police. All parties left the area without further incident. No liquor violations were observed in this incident.
