S2 Express Grill Opens in Richton Park

Revolutionizing Neighborhood Dining

Founded in 2019 by Andre and Suheir Williams, this dynamic husband and wife duo, who bridge African-American and Palestinian heritages, envisioned a place where high-quality cuisine is not a privilege but a local staple.

S2 Express Grill, now located at 4030 Sauk Trail, had a Grand Opening with more than 200 attendees, all excited in support of Richton Park's latest ribbon cutting.

The journey began with a simple yet profound belief by Andre Williams: "You shouldn't have to travel all the way downtown to get a lamb chop or a good surf and turf." As rave reviews pour in, the small bar's fame for its food outgrew its original walls, paving the way for something bigger. In addition to Richton Park, S2 Grill currently has FIVE restaurants in Chicago, also with locations in Orland Park, Harvey, and Maywood.

Choosing locations in the aftermath of the 2020/2021 civil unrest, S2 didn't just see buildings; they saw potential. "Bringing back food that's good to the neighborhood," became more than a slogan - it became a mission. Each S2 Grill stands in a place where other businesses hesitated to return, serving not only meals but hope, proving that from ashes, growth is possible.
